# I. CALL TO ORDER

The meeting was called to order at 10:00 a.m. by Chair Solu.

# II. PUBLIC COMMENT PERIOD

Janice Peters, Mayor, introduced herself as the City Council liaison to the Tourism Business Improvement District Advisory Board.

Jeff Eckles, President of the Morro Bay 4<sup>th</sup> provided a brief report on the financials of the 4<sup>th</sup> of July event. He gave a brief report stating collections were \$41,000; expenses were \$30,000 leaving \$10,000 for seed money for next year; he said a formal written report will be presented in the future.

Tyson Stockton introduced himself and announced his study about residents and their feelings towards tourism.

Steven Nukes discussed the idea of a scenic loop.

John Summer of the VCB thanked the Board in advance for funding.

Bill Yates, Steve Mathieu and Hunter Kilpatrick provided a presentation and request for funding for the Harbor Festival.

Mitch Paskin of White Heron Sangha asked about the possibility of packaging hotel stays with their event.

Christine Rodgers of Energy Watch spoke about the program they offered including the Direct Install Program for businesses and residential energy saving. She provided the phone number of 610-205-3682 for those interested.

Jayne Behman indicated the 4<sup>th</sup> of July event was spectacular. She also thanked Joan for staffing the booth for the entire day.

Member Candela announced the Chamber mixer for July 15<sup>th</sup> at the Antique Emporium, Rock to Pier run on July 17<sup>th</sup>, the spotting of blue whales off the coast, Lost Isle Adventures beginning their tour on the sand spit and oyster tours and filming of the State Parks.

Member Meyers suggested using Tidelands Trust "accumulation" funds to "spruce up" the Embarcadero prior to the Savor and Harbor Festival events.

Rick Turton provided a report on website statistics.

John announced visits on the website were up for June, he further reviewed the specific statistics. John also indicated that according to the web stats, site visits came from Los Angeles, Fresno, San Francisco, Bakersfield and San Jose in order of popularity.

John also reviewed the Jackrabbit Reservation System and as a result there has been a decrease in visits to the lodging guide on the website, but made up by 1500 visiting the Jackrabbit Site.

John reported that 805-Living will be doing a press tour with a story on dining in September. The Tourism Business Improvement District Advisory Board will be looking at their budget and looking at coop advertising with other Business Improvement Districts.

John is working on the twinning or sister City with Gibraltar with a press release.
