## NOTICE TO VOTERS OF DATE AFTER WHICH NO ARGUMENTS FOR OR AGAINST A CITY MEASURE MAY BE SUBMITTED TO THE CITY CLERK

### City of Morro Bay

**NOTICE IS HEREBY GIVEN** that the General Municipal Election is to be held in the **City of Morro Bay** on Tuesday, November 8, 2022, at which there will be submitted to the voters the following:

Shall the measure, to exclusively fund City of Morro Bay owned harbor infrastructure (such as docks, piers, Harbor Walk, sea walls, public restrooms, revetments, launch ramps) through preventative maintenance and capital improvements, revenues used only for these purposes and unable to be used for any other purpose, providing approximately \$680,000 annually, through annual \$120 special parcel tax on all parcels of taxable real property, adjusted for inflation, until ended by voters, be adopted? **NOTICE IS FURTHER GIVEN**, that in accordance with the requirements of Division 9, Chapter 3, Article 4 of the California Elections Code, the legislative body of the City, or any member or members thereof authorized by the body, or any individual voter or bona fide association of citizens, or any combination of voters and associations, may file a written argument, not to exceed **300 words in length**, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, for or against the City measure(s).

**NOTICE IS FURTHER GIVEN**, based upon the time reasonably necessary to prepare and print the arguments and Voter Information Guide for the election, the City Clerk has fixed **Friday, July 22, 2022 at 5:00 p.m.** as the date after which no primary arguments for the measure may be submitted to the City Clerk for printing and distribution to the voters as provided in Article 4. Arguments shall be submitted to the City Clerk, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, in person by appointment at City Hall, Morro Bay, California. In the alternative, arguments may be submitted by mail to the City Clerk's Office, 595 Harbor Street, Morro Bay, but such arguments must be received before the close of business July 22, 2022. Arguments may be changed or withdrawn until and including the date fixed by the City Clerk.

**NOTICE IS FURTHER GIVEN** that the City Council has determined that rebuttal arguments, not to exceed 250 words in length, as submitted by the authors of the opposing direct arguments, may be filed with the clerk, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, not more than 10 days after the final date for filing direct arguments. Rebuttal arguments must be received by the City Clerk's Office before the close of business **August 2, 2022.**

**NOTICE IS FURTHER GIVEN** any ordinance, resolutions, impartial analysis, or direct argument filed under the authority of the Elections Code will be made available for public examination in the City Clerk's Office for not less than 10 calendar days after the deadline for the filing of resolutions, arguments, and analyses.
